### **An Envision Tonawanda Report**

Envision Tonawanda, a group of City of Tonawanda residents, were concerned about the nature and timing of development proposals in the city as well as a lack of public input into the process. So, earlier this year, Envision Tonawanda held a public meeting and printed, distributed (with assistance from the Tonawanda Senior Center and the Erie County Public Library in the city) and tabulated surveys. Also, surveys (with additional questions) were published online and promoted via social media.

After several weeks the results were collected. No restrictions were put on the ideas, many which already were proposed or had been discussed in the public square. Responses were collected from all Wards and opportunities existed to add ideas which were not specified on the printed surveys.

This report will be given to elected officials and members of the steering committee working on the city's masterplan.

### The respondents

From the online survey, there were 239 responses from City of Tonawanda residents and 10 responses from non-residents. *(one respondent skipped the question)* 

41 respondents lived in Ward 1
47 respondents lived in Ward 2
37 respondents lived in Ward 3
59 respondents lived in Ward 4
65 respondents selected "Not Sure" with regards to Ward residence.



# Part 1 City Hall Complex


# **Online Survey – City Hall**

 Would you support a proposal to move the City Hall complex, off of Niagara Street, to another location so that area of the waterfront can be made available for development?




# **Printed Survey – City Hall**



# City Hall - relocation (Online Survey)


 Would you support the relocation of City Hall to one of these sites, bringing together the City Hall offices, court, police, fire and/or public works building, to make one centrally located public safety building?



# City Hall – relocation (Printed Survey)


 At the former Spaulding Complex (Wheeler and Hackett streets) would you support relocating City Hall, police, fire, courts and public works in one new complex?






# East Niagara Street (Printed Survey)




# Part 3 Ives Pond



 Would you support the construction of homes at the lves Pond location?


42% Yes, 40% No, 18% Undecided




# Part 4 Veterans Park

• Two builders have submitted plans for the development of Little League Drive and Veteran's Park. One plan projects the building of 72 villa- style homes valued at \$250,00 and up. This development would rely on "condo status" being granted and the homes being taxed at only 65% of their value. The second plan looks to build 46 one and two -story style homes valued at \$250,00 and up and would be taxed at 100% of their value. Each development could add between \$190,00 and \$200,000, annually, to the city tax base, once filled to capacity. 

### Veterans Park (Online Survey)


 Please indicate your feelings of importance on developing the 14 acres of land, known as Little League Drive and Veteran's Park.

 Would you support a residential development at Veteran's Park/Little League Drive?



 Would you support expanded sports/recreational facilities at Veteran's Park/Little League Drive?



# Part 5 Spaulding



### 24% Agree, 68% Disagree, 8% No opinion




• In 2007, a company pitched the idea of building a multiuse arena on this site. The facility would have been used for ice hockey, conventions, concerts, trade shows, etc. and had the ability to draw in over 100,000 visitors per year to the city. Unfortunately, the company and hockey rights owners backed out due to time constraints, as the property could not be remediated and ready in a suitable timeframe for them. ### 83% Yes, 8% No, 8% Undecided





# Young Street (Printed Survey)


 Would you support bars and restaurants in a redeveloped section of Young St. between Main and Delaware?

### 4th Ward Comments - continued:

- Repair sidewalks. Update older homes.
- Move city hall to old Clint Small. Move football clinic on East Niagara and Ives Pond to Spaulding Complex. Housing only at Little League Drive, East Niagara St., and Ives Pond. Also water front. Move Niagara Hose Fire Dept. to headquarters on William St.. Put housing on Niagara Hose property. Privatize housing complex on Hinds & Gibson Sts., or demolish for better housing.
- Publicize and/or seek grants for homeowners to improve properties to increase tax base & help homeowners. Increase marketing with new ideas for using the Niawanda Park Pavilion. Evaluate yearly need for current number of elementary schools.
- Legally and in common sense speaking, how was it possible that the right turning lane on Young Street at Smoke on the Water was taken away and given or sold(?) to them? It caused added congestion and possibilities of multiple accidents for 7-10 parking spaces.
